for managing stakeholder engagement

We, Seqirus UK Limited ("Seqirus"), are committed to protecting your personal data in compliance with applicable laws and regulations. This privacy notice explains what personal data we collect for managing stakeholder engagement activities; the means by which we collect, use, and share personal data; how we store, process and protect this information; and the associated data privacy rights.

What personal data do we collect and why?

Personal data is information that relates to a person who is, or who could be, identified, such as your name, address, telephone number or email address.

We collect and process the following categories of personal data in connection with stakeholder engagement to pursue our legitimate interests of identifying stakeholders with whom to engage on specific topics, planning and prioritising activities, and allocating resources:

- name, professional title and role;
- education;
- profession;
- employer and other professional affiliations;
- professional address and contact details such as email address and telephone number;
- contributions to publications and guidelines relevant to our field of activity;
- preferences relevant to our professional interaction;
- publicly accessible information about professional activities;
- information about professional interactions with our company.

We only collect personal data which is relevant and appropriate. We do not collect any sensitive personal data or information about any person's private life in connection with our stakeholder engagement activities.

The sources of the personal data we collect are:

- publicly accessible websites;
- publicly accessible parliamentary records;
- reputable sources of media coverage;
- LinkedIn;
- databases of scientific and medical publications; and
- professional interactions with you and your peers and colleagues.

With whom do we share your personal data?

We could share your personal data with our affiliated companies for the purposes specified in this privacy notice.

We work with third-party service providers who help us with our stakeholder engagement activities or support services such as data hosting. These service providers could have access to your personal data in order to perform their services to us.

We could also disclose your personal data to:

- official authorities if required by law, court order or governmental regulation or if required for an investigation or legal proceeding;
- distributors, license partners or other companies with whom we collaborate, for the purposes specified in this privacy notice; or
- our legal and other expert advisors.

These service providers, collaboration partners and advisors are legally bound to keep all personal data confidential and to use them only to perform the services for which we engaged them.

We could disclose your personal data to third parties in connection with the sale or transfer of all or part of our business, in which case we would require the third parties to treat those data in accordance with this privacy notice.

Some of the above-mentioned recipients of your personal data are located outside the country where you are located, including countries that are not regarded by the competent authorities as providing adequate protection for personal data. In such cases, we ensure that appropriate safeguards are in place to protect your personal data such as EU standard contractual clauses. How long do we store your personal data?

We store your personal data only for as long as necessary to achieve the purpose for which the data were collected.

What are your rights regarding your personal data?

You are entitled at any time to request access to your personal data. You can request that errors be corrected or that processing of your personal data be restricted. You can also object to our processing of your personal data or request them to be erased.
